Why we are consulting

The census counts everyone in England and Wales

The cost and effort of taking a census is only worthwhile when the results are provided to users in ways that allow them to use the information to improve the decisions they make.

Purpose of the census

All kinds of organisations, from local authorities to charities, use census information.

There are two main types of use:

- 1. Describing the population on Census day
- 2. Informing the decisions of the future

We want our outputs to help answer the most important questions facing society today



From questionnaire to outputs

- Between March and May 2021, the population of England and Wales were encouraged to fill in their Census 2021 questionnaire
 - We ran a successful data collection operation and exceeded our 94% target
- We are now processing the responses. This takes time, as the information provided needs to be turned into safe, flexible and accessible outputs. Activities include:
 - filling in any gaps in responses, and deal with multiple returns
 - estimating the level of undercount and adding missing people and households
 - running processes to protect confidentiality of individual responses
 - turning data into accessible outputs
- We are now at the stage where we can share our plans on outputs to get your feedback, before the first release of Census 2021 findings in Spring 2022.

Importance of consulting

Public consultations, in the form of online surveys, allow us to:

- Share our detailed plans, progress and reasoning behind decisions that will impact how users can interact with our data
- Offer a place for any member of the public to provide feedback on our plans and share their requirements
- Collect thorough feedback over a 12-week period
- Identify and address any gaps in our plans that users tell us about

We want to meet as many of your needs as we can.

 If you don't tell us what you need from census data, we might miss something important to you

Aims of this consultation

- The consultation document and supporting materials act as a draft release schedule and indication of our plans
- The consultation is about **what** data we plan to produce
- **How** we produce the data is only discussed where it is relevant to decisions on what we plan to produce
- Results will help us:
 - identify any new or changed data needs
 - prioritise the development of proposed outputs products
 - finalise our release schedule and prospectus
 - develop plans to supplement Census 2021 data



Maximising the value of census data in times of change

- We want to maximise the use and utility of Census 2021 data
- Census has always been a snapshot, but also used as the best estimate for informing decisions many years later, particularly where less alternative information available from other sources
- The current period of societal change will likely mean that some characteristics are subject to more rapid change
- We always planned to combine and supplement census data with other sources, the focus of that work is now slightly different





Release schedule and outputs prospectus

Census outputs range in complexity. In order to begin sharing the data as soon as possible, we are proposing to release Census 2021 outputs in phases.





Summary of proposed release schedule

March 2022 to March 2023

Phase 1 – Release of population and household estimates, univariate data and analysis by topic, and area profiles

Phase 2 – Release of multivariate data and more complex analysis based on usual resident population

Phase 3 – Release of alternative population bases, small population data, origin-destination data and microdata

 Bespoke, restricted, or commissioned outputs

Phase 1 overview

- In Phase 1, we plan to release:
 - Largely ready-made univariate data tables
 - Topic summaries equivalent to the 2011 Census 'Quick statistics'
 - Area profiles similar to the 2011 Census 'Key statistics'
- We're aiming for Output Areas (OAs) to be the main geographical base. These are around 150 households in size.

Area profiles

Simple summary of census data for a chosen geographic area

Phase 2 to 3 overview

- Across phases 2 and 3, we plan to release:
 - Largely multivariate data
 - Data tables equivalent to the 2011 Census 'Local Characteristics' and 'Detailed Characteristics' in phase 2
 - Small population tables, and analytical insights on sub-populations
 - Commissioned table service in phase 3

Census 2021 data dissemination 'hybrid' model

Ready-made tables

- Data tables that contain information down to a particular level that is safe to share across all geographies
- Allowing users to directly compare data from different areas and potentially from previously censuses

Build-your-own table functionality

- Users can request their own combinations of variables and detail for any area or level of geography of interest
- The requested data will only be provided for each geography that the automated disclosure checks determine it is safe to share
- This functionality provides users with flexibility to get more data for areas that are less disclosive than others



For example, you might request data on 340 geographic areas but you will only receive the data for 329 of areas, where the data is safe to provide.

Beyond March 2023 product overview

Beyond March 2023, we plan to release

- More complex analysis of Census 2021 data using other data sources
- UK outputs where data can be compared from:
 - Census 2021 for England and Wales, that we, the ONS, held
 - Census 2021 in Northern Ireland, that the Northern Ireland Statistics and Research Agency held
 - Census 2022 in Scotland
 that the National Records of Scotland will hold in March 2022

Population-base specifications

We're asking what data tables and analysis you need for alternative population bases.

The main population bases for Census 2021 are:

- Usual residents
- Households
- Usual residents in households
- Communal establishments
- Usual residents in communal establishments
- Household reference persons (HRP)

Alternative population bases are those that either:

- move usual residents to different locations
- report on a population that is not usually resident

The alternative population bases for Census 2021 are:

- Workplace
- Workday
- Out-of-term population
- Short-term resident
- Second address

- We're asking what data tables and analysis you need for small populations.
- Our initial proposal is to produce tables equivalent to those published in 2011. These include local-authority-level tables by five-year age bands by sex, for 30 population groups.

Taking a census during a period of change

- We want to help answer the most important questions facing society today
- We need to understand the impact the current period of societal change has had on your needs for:
 - Place of residence data
 - Economic activity and employment data
 - Travel to work data
 - Workplace zones (geography)
 - Migration, health, unpaid care etc...
- Impacts may include new, changed or reprioritised needs

How we will use your feedback





How we will evaluate your feedback

- We will use the information you provide to:
 - identify any new or changed data needs
 - prioritise the development of proposed outputs products
 - finalise our release schedule and prospectus
 - develop plans to supplement Census 2021 data
- The evaluation will seek to balance:
 - The strength of need for the requested census data
 - How publication of the requested data will serve the public good
 - Other considerations, such data quality, disclosure control and cost





Serving the public good

The purpose to which the data will be put is central to the evaluation process. Purposes include:

- resource allocation
- service planning
- policy evaluation
- diversity monitoring

Implications if the requested data are not produced are also important. Implications include:

- increased financial costs
- reduced quality of data used in decision making
- not meeting legislative requirements

The Census 2021 outputs consultation

- Will remain open from 13 July 2021 to 5 October 2021
- Is hosted on Citizen Space, the ONS's online survey hub
- Users can respond by:
 - Filling in the <u>online questionnaire</u>
 - Submitting a downloaded version of questionnaire, in English or Welsh, via email or post. This is available from the 'related links' section at the bottom of the <u>online questionnaire</u> homepage.

What we're asking

- We're asking you to feedback on the proposals we have published in our consultation document: <u>Census 2021 outputs: content design and release phase proposals</u>
- Our proposals, in both the consultation document and <u>online questionnaire</u>, have been grouped into sections to help you find the topics you would like to consult on
 - Shape of the outputs and analysis release schedule
 - Main changes to variables compared to the 2011 Census
 - Proposals for potential new derived variables
 - Population-base specifications
 - Taking a census during a period of change
 - Paradata, information about how we collected the data
